ICD 503. In 2008, the Director of National Intelligence signed IC Directive 503, “Intelligence Community Information Technology Systems Security Risk Management, Certification and Accreditation.”. ICD 503 replaced DCID 6/3, and is today the relevant guidance for the risk management and certification of information systems across the IC. This standard specifically requires the IC to use NIST or CNSS standards for security certification assessment and testing.

ICD503/DCID 6/3 Compliance. The Director of Central Intelligence Directive 6/3 governs the protection of sensitive compartmented information within Information Systems. The Director of Central Intelligence requires all United States Government departments and agencies, their contractors, and Allied governments processing intelligence information to establish, implement, maintain, and abide by the protection measures identified.
